1. Beer: max quantity: 24 tins. Wine and Spirits: max quantity: 10L (2.6gal). Liqueurs: max quantity: 5L (1.3gal). Delay: 48 hours, due to clearance by Ministry of Health.
2. Need inspection by Ministry of Communications and Works. Delay 24 hrs.
3. Need inspection from Ministry of Agriculture
4. Consignee requires permit from CYTA (government telecommunications company).
5. Consignee must provide import license from Ministry of Health. Invoice must have full description of goods. Delay: 24 hrs.
6. The clearance procedure can only be made , provided that the consignee is present.
7. Need inspection by Ministry of Commerce, Industry and Tourism. Delay 24 hrs.
8. Consignee requires permit from Ministry of Communications and Works.
